## **Professional Masters Programme**

The post holder will work as part of the Professional Masters team within the Department of Computer Science. This is a team of lecturers and professors who teach modules, supervise students, and provide academic support for a programme of advanced education in the areas of software, data, and security engineering.

The Programme offers part-time MSc degrees in Software Engineering and Software and Systems Security; an additional MSc in Data Science or Data Engineering may be offered in the near future. Students take 10 taught modules over three or four years, while also completing a project and dissertation.

Each module is based around a single, intensive week of teaching – lectures, classes, and practical exercises – followed by a written assignment. The Programme is aimed at professionals working full-time in industry, and many of the students may have considerable, relevant experience.

## The role

The post holder will develop and deliver taught modules, set and mark written assignments, and supervise students on the part-time, postgraduate Professional Masters Programme offered by the Department of Computer Science.

The content of the modules, and the expectations of the students, will be at the leading edge of professional practice, and the post holder will be expected to establish and maintain a good understanding of underlying theory and current practice in the subject matter of the modules that they teach.

They will be expected also to act as an effective member of the Programme team, providing appropriate academic support for activities such as student admissions, curriculum development, and University examinations.

The post holder may be asked to deliver six one-week taught modules in each year, in three different subjects, and to provide supervision for between 40 and 50 part-time students.

## Responsibilities

- to plan and organise specific areas of the syllabus and contribute to syllabus development
- to develop content for taught modules within the Professional Masters Programme, comprising lecture notes or slides, class materials, and practical exercises
- to deliver taught modules within the Programme, allocating tasks to and supervising the activities of a teaching assistant
- to support and develop the teaching skills of less experienced members of the team in pedagogy, specialist methodologies, or procedures through observation and feedback
- to produce a written assignment and marking specification for each module delivered, to the satisfaction of the Board of Examiners
- to mark student submissions for each assignment, proposing grades and providing brief reports, again to the satisfaction of the Board of Examiners
- to supervise students on the Professional Masters Programme, attending meetings during the assigned project weeks, and advising on the content and preparation of dissertations
- to act as a first point of contact for student matters relating to attendance, conduct, coursework, performance, and welfare (referring matters to appropriate others).
- to assess submitted dissertations, proposing grades and providing brief reports, again to the satisfaction of the Board of Examiners serve on the Board of Examiners for the Programme
- to maintain a good knowledge and understanding of underlying theory and current practice in the subject matter of the modules taught
- to attend team meetings and make effective contributions to the development, administration, and promotion of the Programme
- to provide academic support for student admissions, interviewing candidates, making recommendations, and participating in selection meetings and discussions

• to serve, periodically, on the Board of Examiners for the Programme, reviewing assignments, submissions, and dissertations, and recommendations

## **Selection Criteria**

#### Essential

- A doctorate in a relevant subject, such as: computer science, software engineering, information security, applied statistics, or mathematics.
- A good understanding of underlying theory and current, industrial practice in software engineering, software and systems security, or data science.
- An aptitude for teaching, and the skills and judgement needed to teach advanced concepts and techniques to working professionals with a range of experiences and expectations.
- A readiness to develop and/or deliver modules in subjects for which there is an existing or anticipated teaching need within the Professional Masters Programme in Computer Science at Oxford.
- A genuine enthusiasm for teaching and learning, and the ability to work effectively as part of a team of academic and administrative staff responsible for delivery.

#### Desirable

- Experience of software, data, or security engineering in a production context
- Experience of teaching software, data, or security engineering
- Experience of delivering training to a professional audience
- Readiness to deliver modules in subjects for which there is an existing teaching need
- Readiness to provide student supervision in all areas of the existing curriculum

#### **Department of Computer Science**

The Department of Computer Science was established in 1957, making it one of the longestestablished Computer Science departments in the country. It is one of the UK's leading Computer Science Departments (ranked first in a number of international rankings). The UK Research Excellence Framework (REF) in December 2014 resulted in 74 members of the Department having 53% of their research activity ranked in the top category of 4\* (worldleading). Overall, we received an average of 3.34 across the Department (3\* being internationally excellent). A significant majority of the Department are active in externally sponsored research, with both government and industrial funding. At present, there are 69 members of academic staff and almost 100 research staff.

The Department has close links with government, industry, and other departments within the University. Among the latter are Mathematics, Engineering, Physics, Statistics and a number of life sciences departments. The Department is housed across multiple sites within the University's South Parks Road Science Area, facilitating strong collaborative links with research groups and institutes in closely allied areas (including the Oxford Internet Institute and the Oxford e-Research Centre). This is an essentially inter-disciplinary activity which is at present attracting major funding from a number of sources. At present, the Department holds over £50m in external research contracts.

Research in the Department is currently managed in ten themes:

- Algorithms & Complexity Theory focusses on determining the inherent difficulty of computational problems, classifying problems according to this inherent difficulty, and designing and analysing algorithms that use computational resources as efficiently as possible;
- Artificial Intelligence & Machine Learning focuses on theoretical foundations, multiagent systems, deep learning and computational linguistics;
- Automated Verification investigates theory and practice of formal verification and correct-by-construction synthesis for software and hardware systems;
- Computational Biology & Health Informatics is concerned with computational approaches for biomedical research and healthcare innovation;
- *Cyber-Physical Systems* is focusing on intelligent and autonomous sensor systems with applications in positioning, healthcare, environmental monitoring and smart cities;
- Foundations, Structures and Quantum embraces interdisciplinary research, and has a particular interest in structural foundations of quantum computation;
- *Human-Centred Computing* covers human-computer interaction, social computing and world-wide web;
- Information Systems covers databases, knowledge representation and reasoning;
- *Programming Languages* covers functional programming, program analysis, and programming language foundations;
- Security specialises in cybersecurity, protocol analysis, systems security, trusted computing, human-centred security, and networking.

#### The Mathematical, Physical, and Life Sciences Division (MPLS)

The Mathematical, Physical, and Life Sciences (MPLS) Division is one of the four academic divisions of the University. Oxford is widely recognised as one of the world's leading science universities. The disciplines within the MPLS Division regularly appear at the highest levels in world rankings. In the results of the six-yearly UK-wide assessment of university research, REF2014, the MPLS division received the highest overall grade point average (GPA) and the highest GPA for outputs. We received the highest proportion of 4\* outputs, and the highest proportion of 4\* activity overall. More than 50 per cent of MPLS activity was assessed as world leading.

The MPLS Division's 10 departments and 3 interdisciplinary units span the full spectrum of the mathematical, computational, physical, engineering and life sciences, and undertake both fundamental research and cutting-edge applied work. Our research addresses major societal and technological challenges and is increasingly focused on key interdisciplinary issues. We collaborate closely with colleagues in Oxford across the medical sciences, social sciences and humanities, and with other universities, research organisations and industrial partners across the globe in pursuit of innovative research geared to address critical and fundamental scientific questions.

MPLS is proud to be the home of some of the most creative and innovative scientific thinkers and leaders working in academe.
