Additional information	Whilst the role is a Grade 7 position, we would be willing to consider candidates with potential but less experience who are seeking a development opportunity, for which an initial appointment would be at Grade 6 (Grade 6: £30,502 - £36,386 p.a.) with the responsibilities adjusted accordingly. This would be discussed with applicants at interview/appointment where appropriate. As this post will be for under 7 months it will not meet the financial threshold for visa sponsorship so you will need the Right to Work in the UK already to be eligible for this role.

The Role

The Department of Computer Science at the University of Oxford is currently looking for one Research Software Engineer / Research Assistant to help prototype a software system aimed to provide a first line of defence against phone fraud for older adults with memory concerns.



Voice-based social engineering attacks, commonly delivered as phone fraud, can be devastating to older adults, both financially and emotionally. This demographic are among the most common targets of criminals perpetuating such attacks; not only do they have the most financial savings at stake, but they also are the most easily persuaded due to cognitive and memory concerns. They also are often the least familiar with such attacks and the tactics behind them.

This project aims to develop a system that can robustly defend older adults against such voice fraud, using conversational analysis (CA) applied to real-time AI-based transcription. The system aims to also play a foundational role in cyber situational awareness by collecting evidence of such attacks globally.

This project has a goal of reaching a technology readiness level (TRL6 or above) that the system can be validated for potential tech transfer into an industry spin-out. The extension of the position is subject to excellent performance and funding availability. It is funded as by the UK's Research and Innovation (UKRI) Engineering and Physical Sciences Research Council (EPSRC) through the <u>PETRAS National Centre of Excellence for Cybersecurity and IoT</u> Internal Strategic Projects and Engagement Fund (ISPEF).

Candidates would ideally be a full-stack developer with experience in Python and JavaScript have some applied machine learning experience in natural language processing, and some experience with audio/speech processing or telephony (VoIP) systems. Previous experience with developing medical technologies for vulnerable populations is an asset.

Candidates must have a Right to Work in the UK. Flexible (hybrid) remote/local work arrangements can be arranged, so relocation to Oxford is not a necessity.

Responsibilities/duties

It is intended that the post holder will work with a team led by PI Prof. Max Van Kleek and Co-Investigator Dr. Peter Novitzky at University College London to help further develop a conceptual prototype to proof of concept phase.

This will involve the following activities

- Make key design decisions for the system architecture towards realising the RED-AID proof of concept.
- Lead software development and testing of the prototype.
- User needs identification and essential UX design and testing with key user stakeholders, including interviews and co-design sessions with older adults with memory concerns

The implementation will use popular ML libraries and a Web technology stack, which will involve phone conversation audio processing, back-end implementation and implementation of a basic front-end UI.

Selection criteria

Essential

- Hold a PhD/DPhil or be close to completion in Computer Science or Engineering* to be appointed at Grade 7; or for under-fill at Grade 6, hold a Bachelor or Master's degree in Computer Science or Engineering
- Full-stack developer experience with multiple programming languages, including Python and JavaScript
- Experience leading agile software development in a small team.
- Experience building software that involves audio processing

Desirable

- Experience in applied machine learning, especially natural language processing.
- Experience in Human-Computer Interaction, User Experience Design.
- Experience with VoIP and building systems that interface with Asterisk/IP-based PBXes.
- Experience designing technology for older adults, those with dementia, memory concerns, and other conditions.

*Evidence required:

Department of Computer Science

The Department of Computer Science was established in 1957, making it one of the longestestablished Computer Science departments in the country. It is one of the UK's leading Computer Science Departments (ranked first in a number of international rankings). The UK Research Excellence Framework (REF) in December 2014 resulted in 74 members of the Department having 53% of their research activity ranked in the top category of 4* (worldleading). Overall, we received an average of 3.34 across the Department (3* being internationally excellent). A significant majority of the Department are active in externally sponsored research, with both government and industrial funding. At present, there are 69 members of academic staff and almost 100 research staff.

The Department has close links with government, industry, and other departments within the University. Among the latter are Mathematics, Engineering, Physics, Statistics and a number of life sciences departments. The Department is housed across multiple sites within the University's South Parks Road Science Area, facilitating strong collaborative links with research groups and institutes in closely allied areas (including the Oxford Internet Institute and the Oxford e-Research Centre).
